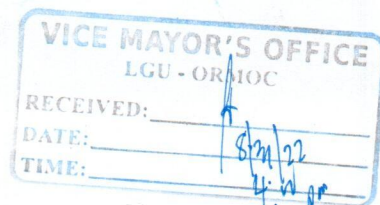
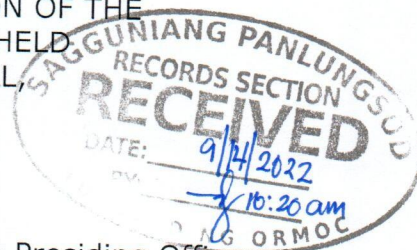

EXPLANATORY NOTE

The City Government of Ormoc gives priority to sports development. The City Government believes that excellence in sports or outstanding performance in sports competitions is a product of a multi-faceted strategy including but not limited to food and nutrition among athletes, sports equipment and supplies, access to good trainers and coaches, support during trainings and actual competition, cash incentives and scholarship grants.

The Sangguniang Panlungsod ng Ormoc already enacted Ordinance No. 049 to provide scholarship grants to ensure that the athletes also pursue their schooling and finish academic degrees to secure their future at the same time bringing honor and prestige to Ormoc City through their performance in sports. On August 3, 2022, the City Mayor endorsed the request to amend said Ordinance No. 049 to consider two matters: (1) expand or increase the benefits that will be granted to athletic scholars, and (2) provide assistance to Ormocanon athletes who are already scholars in the colleges or universities where they are currently enrolled.

The Ormoc City Sports Commission deliberated the proposals and expressed its appreciation to the City Mayor for always looking into the welfare of the athletes. The Commission passed Resolution No. 2, S. 2022 supporting the request of the City Mayor as stated in the above cited paragraph.

WHEREFORE, on joint motion of SP Member Joan Marbie C. Simbajon, Chairperson of the Committee on Youth and Sports Development and SP Member Nolito M. Quilang, Chairperson of the Committee on Education and Manpower Development, severally seconded by SP Members Esteban V. Laurente, Lalaine A. Marcos, Burt J. Pades, Edmund B. Kierulf, Maria Carmen Jean T. Rama, Rey F. Evangelista and Gregorio G. Yrastorza III; be it

RESOLVED, to enact:

ORDINANCE NO. 088
(Series of 2022)

AN ORDINANCE EXPANDING THE BENEFITS UNDER THE ATHLETIC SCHOLARSHIP PROGRAM AND PROVIDING ASSISTANCE TO ORMOCANON ATHLETES WHO ARE ALREADY SCHOLARS OF TERTIARY INSTITUTIONS, AMENDING FOR THE PURPOSE ORDINANCE NO. 049 S. 2020, OTHERWISE KNOWN AS "ORMOCANON SPORTS SCHOLARSHIP PROGRAM ORDINANCE"

Be it enacted, by the Sixteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1. The Section 11 of Ordinance No. 049, S. 2020 is hereby amended to read as follows:

"SECTION 11. BENEFITS - *Subjects to government auditing and accounting rules, an athletic scholar shall be entitled to the following benefits:*

- a. *Tuition and matriculation fees* - the maximum amount that may be granted under this program shall be Eighteen Thousand Pesos (P18,000.00) per semester to cover tuition and other school fees which shall be payable directly to the school where the scholar is enrolled. **In case** the school uses a trimester academic calendar, the term semester shall mean trimester for purposes of applying the scholarship benefits;
- b. *Monthly stipend* - An amount of Two thousand pesos (P2,000.00) shall be granted to a scholar per month during the academic calendar. This benefit maybe available during summer classes when said summer term is included in the curriculum of the course as shown in the prospectus or as certified by the Dean of the college of the university where the scholar is enrolled;
- c. *Textbook Allowance* - Semestral allocation for books in the amount of Four Thousand Pesos (P4,000.00)
- d. *Sports Supplies Allowance* - shall be given to athletic scholars in the amount of One Thousand Five Hundred (P1,500.00) per month."

SECTION 2. SPORTS SUPPLIES ALLOWANCE ON OTHER ATHLETIC SCHOLARS. Sports Supplies Allowance may also be given in the amount of One Thousand Five Hundred (P1,500.00) per month to the Ormocanon athletes who are already scholars in tertiary institutions where they are currently studying as may be further determined by the Ormoc City Sports Commission.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. Within sixty (60) days following the approval hereof, the Ormoc City Sports Commission shall formulate and issue the appropriate rules and regulations necessary for the effective and efficient implementation of this Ordinance.

SECTION 4. SEPARABILITY CLAUSE. The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid or unconstitutional, the remainder, or any provision hereof not affected, shall remain valid and effective.



SECTION 5. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations inconsistent with contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.


SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and after compliance with publication and posting requirements pursuant to the relevant provisions of the Local Government Code of 1991.


