AN ORDINANCE INSTITUTIONALIZING THE SIDLAK ORMOC KABARANGAYAN AWARDS TO BE HELD ON THE SECOND FRIDAY OF DECEMBER OF EACH YEAR

EXPLANATORY STATEMENT

The Constitution of the Philippines recognizes the importance of local governments. It provides as a policy that "the State shall guarantee and promote the autonomy of the local government units, especially the barangays, to ensure their fullest development as self-reliant communities.";

The barangays, known as the basic political unit, serve as the primary planning and implementing unit of government policies, plans, programs, projects and activities in the community, and as a forum where individual and collective views of the people may be expressed, crystallized and considered, and at the same time, where dispute may be amicably settled;

Recognizing the vital and indispensable role of the barangays, the Department of the Interior and Local Government (DILG) has issued Memorandum Circular (MC) No. 2018-194, dated November 6, 2018 with the subject: "2018 Seal of Good Local Governance for Barangay (SGLGB), to encourage and challenge all barangays to scale up its performance and practices of good governance that accord primacy to the principles of accountability, transparency, performance and participation; these are considered the strategic foundations of a responsible local government;

SGLGB will be a progressive performance assessment system that gives barangays distinction for their remarkable performance across governance areas, putting primacy to integrity and good performance as pillars of meaningful local autonomy and development. It is envisioned to be an award, incentive, honor and recognition-based program for all barangays which encourages their commitment to continuously progress, improve their performances along various governance areas, and become champions of good barangay governance in their areas of jurisdiction;

The City Government of Ormoc is highly committed to the virtue of competent local governance especially at the barangay level. Thus, inspired by DILG MC No. 2018-194 and DILG MC No. 2021-074, the 2021 Pilot Testing of SGLGB, the City Government of Ormoc has implemented the Annual Sidlak Ormoc Kabarangayan Awards in 2021 and 2022 as a localized award, incentive, honor and recognition-based program for all barangays in Ormoc City. The program has encouraged the barangays to aspire for excellence and aggressively scale up interventions aimed at the practice of good governance;

DILG Ormoc City and the City Government of Ormoc believe that part of improving the services in the barangay is giving due recognition to the barangays and the many men and women who truly put passion and service together and excel in embodying the tenets of good local governance. With its two years of successful implementation, the Sidlak Ormoc Kabarangayan Awards deserves to be institutionalized to continue challenging the barangays to put up their best efforts in order to win the awards;

Be it enacted by the 16th Sangguniang Panglungsod in its Regular Session duly assembled, that:

SECTION 1. TITLE - This Ordinance shall be known as "**THE SIDLAK ORMOC KABARANGAYAN AWARDS.**"

SECTION 2. PURPOSE - There shall be an established and institutionalized Annual Sidlak Ormoc Kabarangayan Awards in the government of Ormoc City which shall be held on the 2nd Friday of December in every year. The purpose of which is to conceptualize an institutional framework or system of recognition and incentive awards for barangay governments.

SECTION 3. COVERAGE - All Barangays within the territorial jurisdiction of Ormoc City.

SECTION 4. CATEGORIES FOR ASSESSMENT - The assessment shall be conducted using the SGLGB Assessment Tools based on DILG Memorandum Circular No. 2021-074 and shall cover the following SGLGB areas:

CORE AREAS:

- A. Safety, Peace and Order
- B. Financial Administration and Sustainability
- C. Disaster Preparedness

ESSENTIAL AREAS:

- A. Social Protection and Sensitivity
- B. Business-Friendliness and Competitiveness
- C. Environmental Management

SECTION 5. AWARDS - The Awards shall be as follows:

- A. Ten Outstanding Barangays of the Year
- B. Exemplary Performance in Safety, Peace and Order
- C. Exemplary Performance in Financial Administration
- D. Exemplary Performance in Disaster Preparedness
- E. Punong Barangays of the Year
- F. Sangguniang Barangay Member of the Year
- G. Sangguniang Kabataan Chairperson of the Year
- H. Barangay Secretary of the Year
- I. Barangay Treasurer of the Year
- J. Lupong Tagapamayapa of the Year
- K. Barangay Tanod of the Year
- L. Barangay Health Worker of the Year
- M. Barangay Nutrition Scholar of the Year

- N. Day Care Worker of the Year
- O. Barangay Population Volunteer of the Year
- P. Outstanding Barangay Anti-Drug Abuse Council (BADAC)
- Q. Outstanding Barangay Peace and Order Committee (BPOC)
- R. Outstanding Barangay Council for the Protection of Children (BCPC)
- S. Outstanding Barangay Ecological Solid Waste Management Committee (BESWMC)
- T. Special Awards as may be determined by the committee

SECTION 6. AWARDING MECHANISM.

- A. The awardees shall be announced in an Awards Ceremony organized by the City Government, DILG Ormoc City and the Liga ng mga Barangay - Ormoc City Chapter.
- B. Every awardee for each category shall receive the following:
 - 1. Medal of Commendation
 - 2. Plaque of Commendation
 - 3. Special Prizes to be determined by the City Government thru the Sidlak Ormoc Kabarangayan Awards Committee
- C. The decision of the Committee shall be final and non-appealable

SECTION 7. SIDLAK ORMOC KABARANGAYAN AWARDS COMMITTEE (SIDLAK COMMITTEE) - There shall be a City SGLGB/Sidlak Ormoc Kabarangayan Awards Committee in-charge of the over-all implementation of this Ordinance composed of the following:

- Chairperson : City Mayor
- Co-Chairperson : City Local Government Operations Officer, DILG-Ormoc
- Members : City Administrator
City Director, Ormoc City Police Office
City Budget Officer
City Disaster Risk Reduction and Management Officer
Liga ng mga Barangay President/Representative
Business Permits and Licensing Officer
Environment and Natural Resources Officer
City Social Welfare and Development Officer
City Health Officer
Civil Service Organization (CSO) Representative

SECTION 8. SIDLAK COMMITTEE SECRETARIAT. - The DILG personnel shall perform the secretariat functions of the Sidlak Committee.

SECTION 9. IMPLEMENTING RULES AND REGULATIONS. - Within sixty (60) days after the enactment of this Ordinance, the Committee shall formulate the appropriate rules and regulations necessary to effectively implement any or all of the provisions of this Ordinance. Such rules and regulations shall include among others, guidelines on the criteria, qualifications, nominations, judging, and prizes.

SECTION 10. ALLOCATING AMOUNT AS FUNDS FOR THE AWARDS AND CASH INCENTIVES. - The appropriation for the annual implementation of Sidlak Ormoc Kabarangayan Awards, and every year thereafter, shall be taken from the Sidlak Development Program, which shall be established under the City Mayor's Office to be used for awards and incentives, subject to the availability of funds.

This fund shall be used by the barangays for capacity development (CAPDEV), trainings and other MOOE to ensure an effective and efficient implementation of priority barangay development projects and programs based on the implementing guidelines of the Sidlak Committee, subject to accounting and auditing rules and regulations.

SECTION 11. SEPARABILITY CLAUSE. - If for any reason, any provision, portion or part of this Ordinance is found to be inconsistent with any law, other provisions or parts thereof not so affected thereby shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE. - Any ordinance, rules and regulations, resolutions or part thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY. - This Ordinance shall take effect immediately after complying with the necessary publication and posting requirements as mandated by law or the Local Government Code of 1991.






