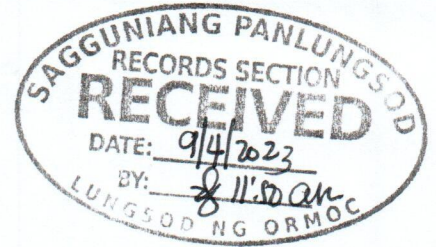

AN ORDINANCE AMENDING THE TITLE, SECTION 1 AND SECTION 2 OF ORDINANCE NO. 104, SERIES OF 2023, ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE SIDLAK ORMOC KABARANGAYAN AWARDS TO BE HELD ON THE SECOND FRIDAY OF DECEMBER OF EACH YEAR"

EXPLANATORY NOTE

To recall, Ormoc City Ordinance No. 104, Series of 2023, otherwise known as "The Sidlak Ormoc Kabarangayan Awards Ordinance" was enacted by this Sanggunian on March 28, 2023 for the purpose of conceptualizing an institutional framework or system of recognition and incentive awards for barangay governments to be held on the second Friday of December in every year.

Pursuant to COMELEC Resolution No. 10899 which provides for the Calendar of Activities for Barangay and SK Elections 2023, the Election Day falls on the last Monday of October 2023 which is earlier than the scheduled date for the Sidlak Ormoc Kabarangayan Awards.

The Department of the Interior and Local Government – Ormoc City, headed by CLGOO Jean Redi T. Briones, who serves as the Co-Chairperson of the Sidlak Ormoc Kabarangayan Awards Committee (Sidlak Committee), suggested for an earlier date for the giving of due recognition to the barangays before a new set of barangay officials put in place, necessitating therefore of this august Body to amend the title of Ordinance No. 104, Series of 2023 and leave to the discretion of the Sidlak Committee to set the date of the Awards. The amendment sought is for the purpose of responding to the observation of the DILG-Ormoc.

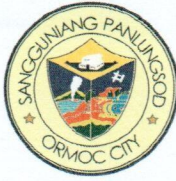
Foregoing premises considered, this Sanggunian finds merit in the request for correction and amendment of relevant provisions of Ordinance No. 104, Series of 2023.

BE IT ORDAINED by the 16th Sangguniang Panlungsod ng Ormoc, in a Regular Session duly assembled that:

SECTION 1. The title of Ordinance No. 104, series of 2023 is hereby amended to read as follows: **"AN ORDINANCE INSTITUTIONALIZING THE SIDLAK ORMOC KABARANGAYAN AWARDS TO BE HELD ONCE IN EVERY YEAR."**

SECTION 2. Section 1 of Ordinance No. 104 is hereby amended to read as follows:

"Section 1. SHORT TITLE. This ordinance shall likewise be known as **"THE SIDLAK ORMOC KABARANGAYAN AWARDS."**

SECTION 3. Section 2 of Ordinance No. 104 is hereby amended to read as follows:

"SECTION 2. PURPOSE - The Annual Sidlak Ormoc Kabarangayan Awards shall be institutionalized in the government of Ormoc City which shall be held on the date to be determined by the Sidlak Ormoc Kabarangayan Awards Committee (Sidlak Committee). The purpose of which is to conceptualize an institutional framework or system of recognition and incentive awards for barangay governments."

SECTION 3. SEPARABILITY CLAUSE - If for any reason, any provision, portion or part of this Ordinance is found to be inconsistent with any law, other provisions or parts thereof not so affected thereby shall remain in full force and effect.

SECTION 4. REPEALING CLAUSE - Any ordinance or provision thereof in conflict with this Ordinance is hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY - This Ordinance shall take effect after complying with the publication and posting requirements under the Local Government Code of 1991.
